## 3. Performance Rules

- Performance is by Market Manager schedule or approval only and must remain in the assigned performance area.
- Regular performance hours are 9:00 AM-1:00 PM. Sound check may begin no earlier than 8:45 AM unless otherwise approved.
- Keep all City sidewalks, building-side sidewalks, entrances, exits, aisles, pedestrian gaps, tenant sight lines, and neighboring vendor spaces clear.
- Amplification must remain modest. Normal market target: 70 dBA or less approximately 10 feet in front of the performance area, and lower whenever necessary to avoid interfering with normal conversation or tenant operations.
- The Market Manager may order immediate volume reduction, pause, relocation, or termination of amplified sound.
- Tip jars are permitted within the performer area. Do not block walkways or pressure customers for tips.
- Merchandise or recording sales require advance approval and must stay within the performer area or a separately reserved vendor booth.

- Unless a separate written agreement provides payment, performers participate for tips only. No audience or tip level is guaranteed.
- Performers are responsible for instruments, equipment, safe setup, and rights applicable to recordings, backing tracks, or other materials they supply. Nothing in these rules shifts any licensing obligation that applicable law places on the Market or venue operator.
- Threats, targeted harassment, unsafe conduct, or unlawful obscene conduct are prohibited. Operational decisions are based on safety, noise, tenant impact, circulation, and market function.
